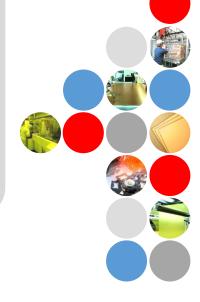

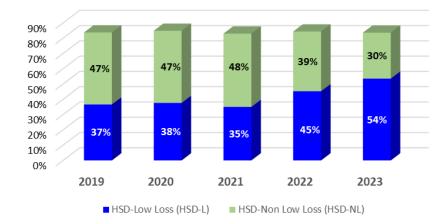

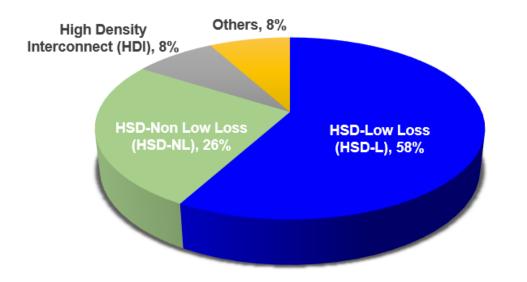

1Q24 CCL Revenue by Technology

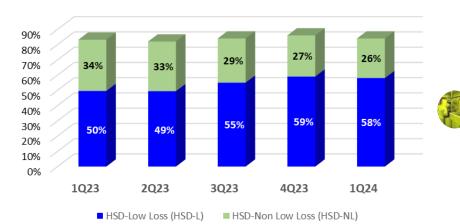




Revenue (%)
