as provided by Taiwan Union Technology Corporation (hereinafter referred to as "TUC Taiwan"), 803 Bo-ai St., Zhubei, Hsinchu County 302045, Taiwan, in the GHG Assertion in the form of GHG report covering GHG emissions of the period 01 January 2021 to 31 December 2021.

Roles and responsibilities

The management of TUC Taiwan is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is SGS's responsibility to express an independent GHG verification opinion on the GHG emissions as provided in the GHG Assertion for the period 01 January 2021 to 31 December 2021.

SGS conducted a third-party verification of the provided GHG assertion against the principles of ISO 14064-1:2018, ISO 14064-3:2006 in the period 05 September 2022 to 23 September 2022. The verification was based on the verification scope, objectives and criteria as agreed between TUC Taiwan and SGS on 08 March 2022.

Level of Assurance

The level of agreed assurance for category 1 and category 2 of TUC Taiwan (Headquarters) is reasonable assurance. The level of assurance for category 1 and category 2 agreed of other sites that are verified remotely is that of limited assurance. Category 3 till category 6 agreed is that of limited assurance.

Scope

TUC Taiwan has commissioned an independent verification by SGS Taiwan of reported GHG emissions of TUC Taiwan arising from Copper Clad Laminate • Prepreg • Mass Lamination Service activities, to establish conformance with ISO 14064:2018 principles within the scope of the verification as outlined below.

This engagement covers verification of emission from anthropogenic sources of greenhouse gases included within the organization's boundary and is based on ISO 14064-3:2006.

Objective

Criteria

Criteria against which the verification assessment is undertaken are the principles of ISO 14064-1:2018.

Materiality

The materiality required of the verification was considered by SGS to 5%, based on the needs of the intended user of the GHG Assertion.

Conclusion

TUC Taiwan provided the GHG assertion based on the requirements of ISO 14064-1: 2018. The GHG information for the period 01 January 2021 to 31 December 2021 disclosing emissions of 364,914.223 metric tonnes of CO₂ equivalent and 0.0000 metric tonnes of direct CO₂ emissions from the combustion of biomass are verified by SGS to a reasonable level of assurance of TUC Taiwan (Headquarters), and a limited level of assurance of other sites that are verified remotely, consistent with the agreed verification scope, objectives and criteria.

We conducted our verification with regard to the GHG assertion of TUC Taiwan which included assessment of GHG information system, monitoring and reporting plan/protocol. This assessment included the collection of evidence supporting the reported data, and checking whether the provisions of the protocol reference, were consistently and appropriately applied.

In SGS's opinion the presented GHG assertion

- is materially correct and is a fair representation of the GHG data and information, and
- is prepared in accordance with ISO14064-1:2018 on GHG quantification, monitoring and reporting.
